CLEANING AND STORAGE

MAINTENANCE: Pitted, scratched or damaged lenses must be replaced by replacing the complete product. If the frame is damaged also replace the complete product. After each use it is recommended to keep the glasses or goggles in a microfiber pouch or rigid case.

STORAGE: All products must be stored in a dry and clean environment.
